Sealed proposals will be opened in the presence of observe's and the proponent's representatives who choose to attend. Late proposals shall not be accepted.

The City Government of Muntinlupa reserves the right to accept or reject any or all proposals, to annul the negotiated process, and to reject all proposals at any time prior to contract award, without thereby incurring any liability to the affected proponents.
