**WHEREAS**, Republic Act No. 10121 or the *Philippine Disaster Risk Reduction and Management Act of 2010* (Signed into Law on May 27, 2010), "**An act strengthening the Philippine Disaster Risk Reduction and Management System, providing for the National Disaster Risk Reduction and Management Plan appropriating funds therefore and for other purposes**";

**WHEREAS**, Section 21 of Republic Act 20121, provides that, "**the Local Disaster Risk Reduction Management Fund amounting to not less than 5% of the estimated revenue from the regular sources shall be set aside to support disaster risk management activities such as, but not limited to pre-disaster preparedness programs and post disaster activities**";

**WHEREAS**, to properly utilize the **Local Disaster Risk Reduction Management Fund (LDRRMF)**, a comprehensive Muntinlupa City Risk Reduction management Plan was developed outlining the program, the course of implementation and action for disaster risk management;

**WHEREAS**, the development of the Plan has been a complex process and designed to match the lesson learnt from natural disaster elsewhere throughout the country in order to identify the risk and potential hazard so that the vulnerability to the same may be reduced by embracing the steps to mitigation, prevention and preparedness, response, rehabilitation and recovery;

**WHEREAS**, Muntinlupa **City Disaster Risk Reduction and Management Plan (MCDRRMP)** 2017-2022 comprised of the following thematic areas:

- 1) **Disaster Preparedness**
- 2) **Disaster Response**
- 3) **Disaster Prevention and Mitigation**
- 4) **Disaster Rehabilitation and Recovery**


