As a result of a second failure of public bidding, the City Government of Muntinlupa now invites proposals for the following contracts, to wit: **Construction of Muntinlupa City Museum & Arts Center (Phase 3: Audi Visual System & Theater Acoustical Treatment) at Museum Centennial Avenue, Tunasan, Muntinlupa City** with the total **Approved Budget for the Contract (ABC) of Thirty Three Million Nine Hundred Thirty Four Thousand Five Hundred Thirty Pesos and 64/100 (P33,934,530.64)**, based on the Specifications, Drawings and Bill of Quantities hereto attached, and using the Financial Proposal, Cost-Breakdown and Detailed Bid Form likewise hereto attached.

The procedures of negotiated procurement will be observed and followed, pursuant to Sec. 53.1 of the Revised Implementing Rules and Regulations (IRR) of R.A 9184.

Opening of sealed proposals shall be on **August 30, 2018, 2:00 p.m. at the City Administrator's Office, Conference Room, 2/F City Hall Main Bldg., National Road, Putatan, Muntinlupa City**, which shall be open to all interested parties. Sealed proposals will be opened in the presence of observe's and the proponent's representatives who choose to attend. Late proposals shall not be accepted.

The City Government of Muntinlupa reserves the right to accept or reject any or all proposals, to annul the negotiated process, and to reject all proposals at any time prior to contract award, without thereby incurring any liability to the affected proponents.
