### **INVITATION TO BID FOR THE PROVISION OF SECURITY & PROTECTION SERVICES FOR CITY HALL OF MUNTINLUPA AND SPORTS COMPLEX & OTHER PREMISES (2019) (\*RE-POSTED)**

1. The City Government of Muntinlupa, through its duly-approved Executive Budget for 2019 intends to apply the sum of **Six Million Four Hundred Twenty Seven Thousand Five Hundred Seventy Pesos and 55/100 (P6,427,570.55)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Provision of Security & Protection Services for City Hall of Muntinlupa and Sports Complex & Other Premises (2019) (\*Re-posted)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The City Government of Muntinlupa now invites bids for the **Provision of Security & Protection Services for City Hall of Muntinlupa and Sports Complex & Other Premises (2019) (\*Re-posted)**. The schedule of delivery shall be in accordance with Section VI. Schedule of Requirements. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from City Government of Muntinlupa and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **January 18, 2019** from the address below and upon payment of the applicable fee for the Bidding

6. The City Government of Muntinlupa will hold a Pre-Bid Conference on **January 25, 2019**, 1:00 p.m. at the City Administrator's Conference Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 6, 2019**, 1:00 p.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18

Bid opening shall be on **February 6, 2019**, 2:00 p.m. at the City Administrator's Conference Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of Muntinlupa reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
