9. The GSO shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.

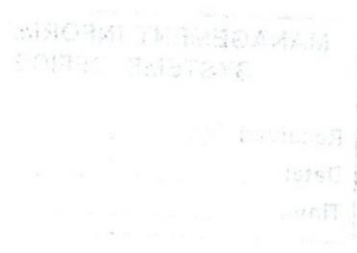
