WHEREAS, Article 2, Section 17 of the 1987 Constitution states that "The State shall give priority to education, science and technology, arts, culture and sports";

WHEREAS, Article 14, Section 2 of the 1987 Constitution states that "The State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";

WHEREAS, Article, 14 Section 10 of the said Constitution states that "Science and technology are essential for national development and progress. The State shall give priority to research and development, invention, innovation and their utilization; and to science and technology education...";

WHEREAS, the City Government of Muntinlupa, through resolutions of the School Board and the City Council, has established the Muntinlupa National High School-Science Annex and classes began in June 1998 at the Itaas Elementary School where it was temporarily located;

WHEREAS, a new four-storey school building located in Barangay Tunasan has been constructed for the use of the selected high school students;

WHEREAS, in order to attain academic excellence and maintain the quality of education of the Science Annex, it is imperative to allocate more funds for the improvement of its facilities and other laboratory equipment;
